#### Methodology:















The decisions taken by the authorities are forwarded for action to be initiated. Meetings were held at the IQAC level, CDC and Governing Body to implement the suggestions in the feedback. Finally, the feedback report was forwarded to IQAC for necessary action and thereafter the analysis is shared with all heads and they are instructed to take necessary measures and actions as to comply with the issues raised by the learners. 



- 3. Few students suggested that there should be extra text book based on new syllabus in library.
- 4. Use of ICT tools by teachers should be increased.


#### FEEDBACK FROM TEACHERS


#### Suggestions from Teachers
